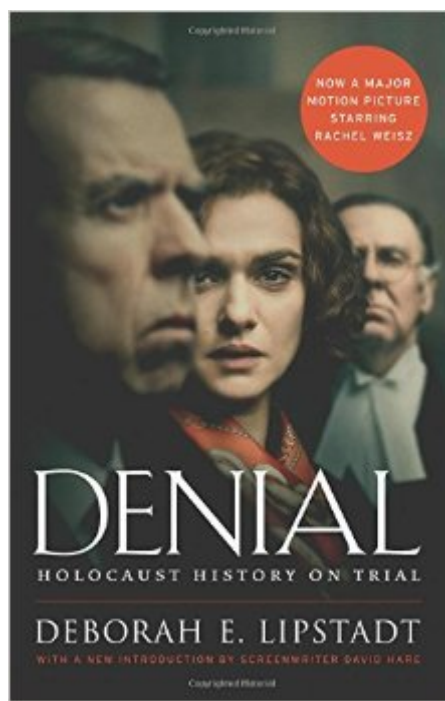

Denial: Holocaust History On Trial

In her acclaimed 1993 book *Denying the Holocaust*, Deborah Lipstadt called David Irving, a prolific writer of books on World War II, "one of the most dangerous spokespersons for Holocaust denial." The following year, after Lipstadt's book was published in the United Kingdom, Irving filed a libel suit against Lipstadt and her publisher.
